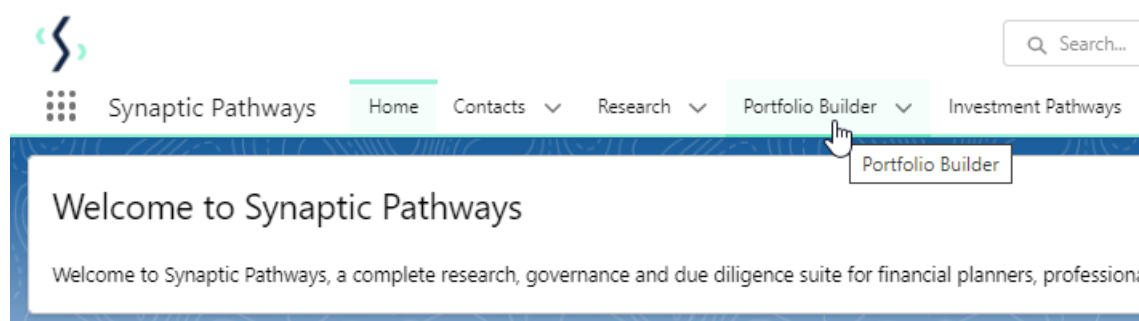


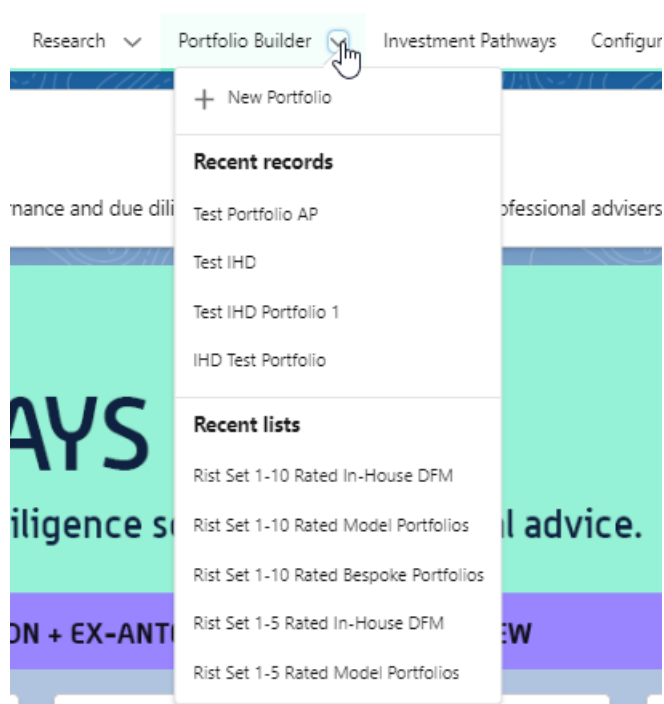

Click on Portfolio Builder in the toolbar:

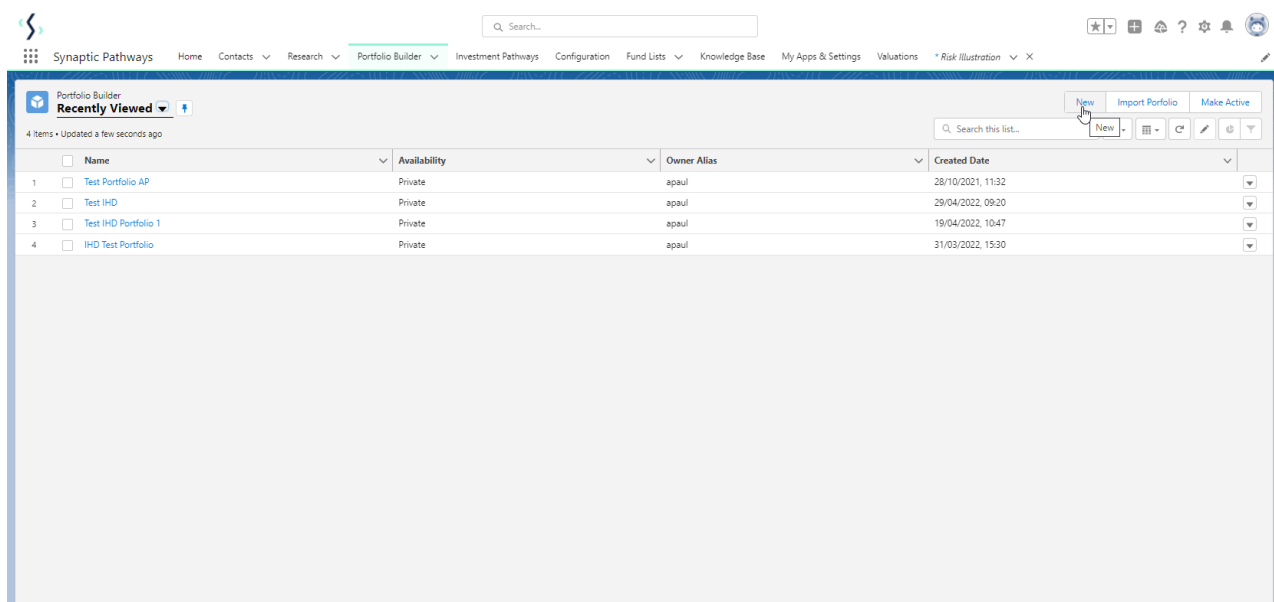


You can either click into the tab or use the dropdown arrow to add a new portfolio or view recent records/lists:

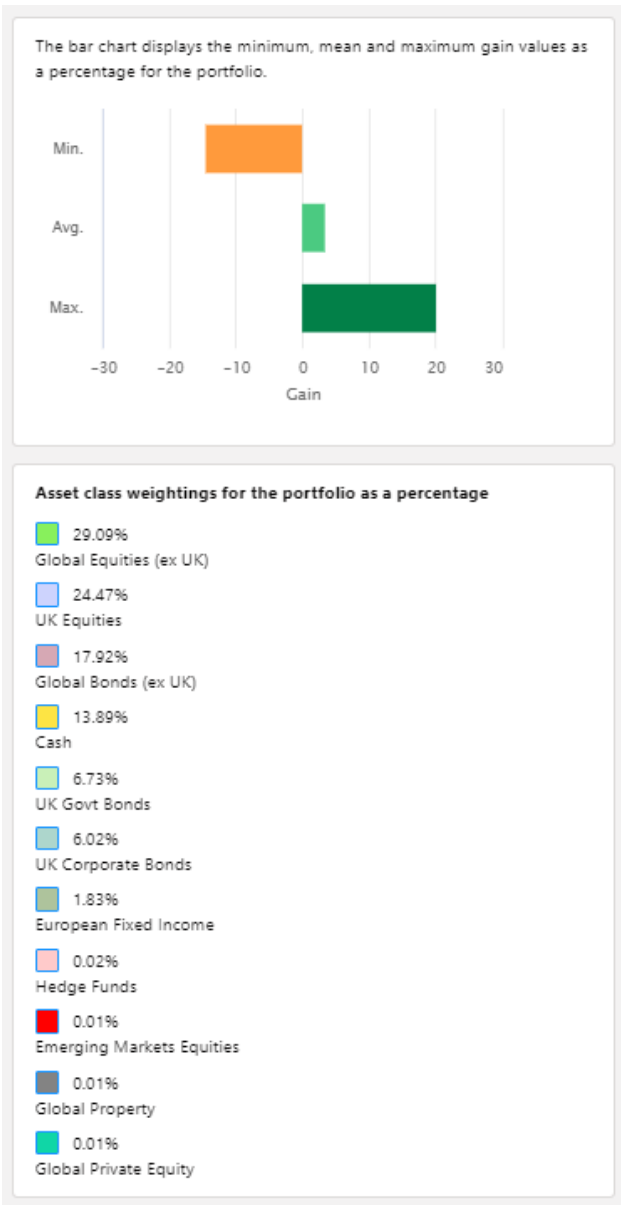
